2- General Rules and Conditions:-

2.1. <u>LANGUAGE OF BID:</u>

The RCO must be prepared in English language only. If any document which is not in English it should be accompanied with translated and attested certified in English version.

2.2. SUBMISSION OF RATE CONTRACT OFFER

- a. Not more than one Rate contract offer will be accepted from any bidder. If an individual/bidder participates in the rate contract offer, representing more than_one bid by one organisation /Individual under One or different names then such multitude of bid shall amount to collusive activity and appropriate action should taken by CGBKVN under the clause 2.19 under the sub –head of fraud and corrupt practices.
- b. Rate contract offer (RCO) have to be submitted through E-tendering online.
- c. The offer should be given in the prescribed format as per RCO document.
- d. The submission of offer by any Bidder implies that they have read the terms and conditions of the RCO and have made themselves fully aware of the scope and specifications of the **Tissue Culture (Teak).** Any addition or omissions in the original offer after opening of the offers will not be entertained.
- e. Individual signing the offer should have valid digital signature and signing other related documents will attach valid acceptable proof of his authority to sign on behalf of the Bidder.
- f. The bidder should fill up the required information in prescribed format and should upload all relevant documents as desired, failing which the bids will be rejected.

2.3. VALIDITY OF THE BID:

- a. The rates quoted by the Bidders shall be valid for 120 days from the Schedule date of submission of the Bid for decision and finalization of the Rate Contract.
- b. In exceptional circumstances, prior to expiry of the original validity period, with mutual understanding the period of validity may be extended for a specific additional period.
- C. If bid could not be finalized within specified period the competent authority may cancel the bid & EMD deposited may be refunded.

2.4. PRESENCE OF BIDDERS:

All the Bidders (or their authorized representative) who respond to this Notification may be present on the date, time and place of Pre bid meeting, opening of Technical Bids and Financial Bid, at their own cost.

2.5. **RATES OFFERED:-**

- a. Rates submitted by the bidder should be firm and free from all escalations.
- b. The bidder should quote rates F.O.R. all Destination in Chhattisgarh supplied through the district Offices of the C.G. B.K.V.N., inclusive of applicable taxes, levies, duties transportations etc.
- c. Bidder within the state/outside of Chhattisgarh:- Bidder should quote the rate as per Technical Specifications of Tissue Culture (Teak). There should be basic rate (Without CGST/ SGST/ IGST but including Transportation F.O.R. destination) and showing Percentage of GST separately and Material wise HSN Number.
- d. Octroi duty or all local taxes if applicable up to the destination shall be paid by the supplier.
- e. Rates should be inclusive of transit insurance any loss or damage of the materials whether insured or not during transit shall be made good by the supplier, free of all charges within one month from the date of intimation to the supplier. If the supplier fails to do so, the consignee will be free to make the losses good at supplier's cost, from any other source.
- f. The rates finalized will be strictly for the use of CGBKVN offices only.
- g. As and when govt. of india or state govt. revised the rate of GST that will be applicable in rate.

2.6. PRE BID MEETING & ISSUE OF CORRIGENDUM

- A prospective Bidder requiring any clarification on the Tender Documents may submit queries in writing on or before date of Pre Bid Meeting at CGBKVN Office.
- b. CGBKVN at its sole discretion may provide response to the queries.
- After Pre Bid Meeting CGBKVN may modify the RCO Document by a corrigendum. Any such corrigendum shall be deemed to be incorporated into this RCO.

2.7. AMENDMENT OF RCO DOCUMENT:

RCO once submitted cannot be amended. However, in some circumstances (such as major anomaly in the technical specifications having a major impact on pricing), the CG Rajya Beej Evam Krishi Vikas Nigam may decide to take fresh RCO from all or any of the Bidders before opening of the financial bid.

2.9. VALIDITY OF RATE CONTRACT:

2.11. FINANCIAL BID

- 2. Bidder may submit rates for all items or less items as he wishes to quote.

2.12. SECURITY DEPOSIT:

- a. The E.M.D. deposited by the successful Bidder, shall be converted to Security deposit, which is refundable after execution of orders successfully or expiry of the RCO as per terms and conditions of RCO. The security deposit will not be carrying any interest.
- b. The Security Deposit shall be retained by CG Rajya Beej Evam Krishi Vikas Nigam Ltd till the currency of rate contract (RCO) or till the final settlement of supply order/payment pending to the satisfaction of consumer, whichever is later.
- c. This security deposit shall be forfeited, in case of failure of execution of supply as per the supply order placed time to time or supply of any substandard material/workmanship reported to be found, and agreement will be terminated and the Bidder may be **blacklisted or debarred** for submission of further rate contract (RCO) through this corporation for the period of 1 to 5 years, as decided by the Managing director CGBKVN.

2.13. PURCHASE ORDER & SUPPLY F.O.R. DESTINATION:

- a) The C.G. B.K.V.N. branch offices/H.O. shall be issuing purchase order on the purchase rates entered into the rate contract so circulated as per the indents or demand received from the various departments, farmer, time to time on consignment basis.
- b) The Bidder has to deliver the requisite quantity of "Material" F.O.R. destination as described in order, which can be District or Block head quarters, or any other

place as the case may be, with their own mode of proper transportation, in proper shape and condition to the consignee, within stipulated time schedule.

2.14. PROCESS OF FINALIZATION OF RATES:-

- (a) After consent of parties and execution of agreement, rates will be circulated as required.
- (b) No offer will be accepted if the rates are quoted with the condition of minimum single order of half/full truck load etc.

2.15. PRICE FALL CLAUSE:

- a) The price charges for the offered item supplied under the contract by the Bidder shall, in no case exceed the lowest price on which the Bidder sells to other parties, private or government bodies.
- b) If at any time during the said period, the Bidder reduces the sale price of such offered item to any other person/organization at a price lower than the price chargeable under the contract, the Bidder shall forthwith notify such reduction in rate to the CG BKVN, The price payable under the contract for the item supplied after the date of coming into force.
- c) Of such reduction in sale price shall stand correspondingly reduced. The C.G. Rajya Beej Evam Krishi Vikas Nigam Ltd. shall be entitled to recover any amount paid in excess to the Bidder in respect of sale which takes place after the reduction of price by the Bidder.
- d) If the rate of similar products (with same specification) is found lower within the State of Chhattisgarh, The Managing Director will have full power to cancel and recover the excess amount paid.

2.16. MODE OF PAYMENT:-

- a) C.G. Rajya beej Evam Krishi Vikas Nigam Ltd. Shall make payment to the supplier on "Payment after Payment basis" against supply for the offered items and after received essential satisfactory report.
- b) All payments against the supplies will be made only in the Name of the supplier on whom the orders for supply are issued. No payment will be made in the name of any other person or firm.
- c) Payment of Suppliers Bill will be made only after getting positive result of samples of supplied materials from a notified laboratory as per requirement of the item.
- d) If due to any mistake extra payment is made to the supplier, it will be responsibility of the supplier to point out extra payment and return it to Nigam. C.G.B.K.V.N. will have full authority to adjust such payments from security deposit or pending bills or next bills due for payment or take any legal action against Supplier.

2.17. PROCESS TO BE CONFIDENTIAL

- a) Information relating to the process of examination, clarification, evaluation and comparison of bids and recommendations for the award of contract shall not be disclosed to Bidders or any other persons not officially concerned with such process.
- b) Any effort by the Bidder to influence the CG Rajya Beej Evam Krishi Vikas Nigam processing of bids or award decisions may result in the rejection of their bid.

2.18. FORCE MAJEURE CLAUSE

Neither party shall be held responsible for the non fulfillment of their obligations under this agreement due to the exigency of one or more of the force majeure events, such as but not limited to acts of God, war, flood, earthquakes, strikes, lockouts, epidemics, riots, civil commotions provided on the occurrence and cessation of any such event the party affected there by shall give a notice in writing to the other party within one month of such occurrence or cessation together with the measures taken by it to mitigate and minimize the adverse effects of such force majeure event. If the force majeure conditions continue beyond six months, the parties shall jointly decide the future course of action.

2.19. FRAUD AND CORRUPT PRACTICES:

The C.G. BKVN requires all the Bidders should observe the highest standard of ethics.

In pursuant to this policy, following has been defined. 'Corrupt Practice' means behavior on the part of officials in the public or private sector by which they improperly and unlawfully enrich themselves and or those close to them, or induce others to do so, by misusing the position in which they are placed, and includes the offering, giving, receiving or soliciting of anything of value. 'Fraudulent Practice' means a misrepresentation of facts in order to influence an evaluation process of execution to the detriment of the Government and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid price at artificial non-competitive level.

In such an event the CGBKVN shall forfeited the EMD and **blacklisted or debarred** the Bidder from participating in future bidding processes of the CGBKVN for period of 1 to 5 Years.

2.20. <u>COMPENSATION OF LOSSES OCCURRED DUE TO SUBSTANDARD</u> / DEFECTIVE SUPPLY AND DEBARRING / BLACKLISTING OF SUPPLIER:

a) The C.G. Rajya Beej Evam Krishi Vikas Nigam Ltd. reserves its right to reject the lot / stock, if any material is not found conforming to specifications mentioned in the supply order or not found up to the mark liable for rejection and should be replaced

immediately by the supplier on receipt of intimation from the consignee, at their own cost. In case the consignment is not replaced within the currency of contract as specified, the consignee may have such material removed at the suppliers risk and the expenses incurred being liable to be recovered from Security Deposit, or from any sum due or which may become due to the supplier. No responsibility shall attach to the consignee for the safe custody of material supplied in excess and not so removed.

b) In case the competent authority feels that the continuation of the rate Contract is not desirable, keeping in view the substandard supplied **Material** he can terminate the same, after issuing a notice, to explain the reason to the satisfaction of the competent authority. The Bidders can also be **blacklisted or debarred** by The Managing Director C.G.B.K.V.N. to carry any further business / supply of such items in the State of Chhattisgarh permanently or temporarily, for a fixed period, as the case may be, if it is found essential in the interest of the state.

2.21 Termination of Contract –

RCO - 61

- a) In case at any point of time bidder is found providing false information, CGBKVN will not execute any rate contract (During process) or will cancel its rate contract (if rate of circulate) and can also be **debarred or blacklisted** from participating in future bidding processes of the CGBKVN for a period of 01 to 05 years.
- b) The Bidder, if breaches any condition or Clause of the Contract the CGBKVN is entitled to Terminate the Contract and also entitled to demand and recover the loss incurred to it due to such termination of the Contract.
- c) If the Government scheme is closed or partly revised or modified, due to Incidental decision of State/Central Government or any amendment and the proceedings of purchase is stopped or revised or modified by the CGBKVN then the Contract will automatically come to any end or partly continues for which Bidder is not entitled to demand/receive any type of loss amount or cannot initiate any legal proceedings against CGBKVN.
- d) In case of the any of the conditions in the RCO document are not fulfilled by the successful bidders it shall amount deemed termination of contract, further more it shall amount to Suspension/Debarment/Blacklisting of Bidder as adopted by CGBKVN.

2.22. CONSEQUENCES OF CONSUMER FORUM AND ANY COURT OF LAW WITH BIDDER:

The supplier shall own full responsibility for the consequences arising out of consumer forum or any court of law, In case any user approaches the Consumer Forum or any court of law with the complaint regarding substandard **of ordered material** supplied to him through the CGBKVN.

2.23. JURISDICTION:

In all cases of legal dispute, only the Raipur Court shall be having the jurisdiction.

2.24. EXECUTION OF AGREEMENT.

- (1) The successful bidder will have to execute an agreement on non-judicial stamp paper of required value with the CGBKVN in the prescribed format within a fortnight from the date of communication of acceptance of his offer by The Managing Director, C.G. Rajya Beej Evam Krishi Vikas Nigam, 'Beej Bhavan' 1st Floor Telibandha G.E. Road Raipur, failing to do so, the earnest money will be forfeited by the CGBKVN.

1.2WHEREAS the BIDDER is a Private Company/Public Company/Government Undertaking/ Partnership/Registered Export Agency, constituted in accordance with the relevant law in the matter and the BUYER is a Ministry/Department of the Government, performing its function on behalf of the Government of Chhattisgarh.

2 OBJECTIVES

NOW, THEREFORE, the BUYER and the BIDDER agree to enter into this pre-contract agreement, hereinafter referred to as Integrity Pact, to avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the Contract to be entered into with a view to:-

- 2.1 Enabling the BUYER to obtain the desired Stores/Equipment/ Work/ Service at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and
- 2.2 Enabling BIDDERs to abstain from bribing of indulging in any corrupt practices in to order secure the contract by providing assurance to them that their competitors will also abstain from bribing any corrupt practices and the BUYER will commit to prevent corruption, in any form, by its official by following transparent procedures.

3 COMMITMENTS OF THE BUYER

THE BUYER commits itself to the following:-

- 3.1 The BUYER undertakes that no official of the BUYER, connected directly or indirectly with the contract, will demand, take promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the contract.
- 3.2 The BUYER will, during the pre-contract stage, treat BIDDERs alike, and will provide to all BIDDERs the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to the other BIDDERs.

3.3 All the officials of the BUYER will report the appropriate Government office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.

In case any such preceding misconduct of the part of such official(s) is reported by the BIDDER to the BUYER with the full and verifiable facts and the same prima facie found to be correct by the BUYER, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the BUYER and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the BUYER the proceedings under the contract would not be stalled.

4. <u>COMMITMENTS OF BIDDERS</u>

The BIDDER commits itself to take all measures necessary to prevent corrupt practices, unfair means & illegal activities during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following:-

- 4.1 The BIDDER will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage, or inducement to any official of the BUYER, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
- 4.2 The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage, or inducement to any official of the BUYER or otherwise in procuring the Contract of forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract with the Government for showing or forbearing to show favour or disfavour to any person in relation to the contract or any other contract with the Government.
- 4.3 The BIDDER further confirms and declares to the BUYER that the BIDDER in the original Manufacture/ Integrator/Authorized government sponsored export entity of the stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the BUYER or any of its functionaries, whether officially of unofficially to the award of the contract to the individual, firm of company in respect of any such intercession, facilitation of recommendation.
- 4.4 The BIDDER, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payment he has made, is committed to or intends to make to officials of the BUYER or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.
- 4.5 The BIDDER will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.

- 4.7 The BIDDER shall not use improperly, for purpose of competition or personal gain, or pass on to others, any information provided by the BUYER as part of the business relationship, regarding plans, technical proposal and business details, including information contained in any electronic data carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.
- 4.8 The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- 4.9 The BIDDER shall not instigate or cause to instigate any third person to commit any of the acts mentioned above.

5. PREVIOUS TRANSGRESSION

- 5.1 The BIDDER declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government Department in India that could justify BIDDER's exclusion from the RCO process.
- 5.2 If the BIDDER makes incorrect statement on this subject, BIDDER can be disqualified from the RCO process or the contract, if already awarded, can be terminated for such reason

6. EARNEST MONEY (SECURITY DEPOSIT)

Every BIDDER while submitting commercial bid, shall deposit an amount as specified in RFP as Earnest Money/Security Deposit, with the BUYER through any of the following instruments:

- 6.1 The Earnest Money should be deposited online from own Account of bidders by RTGS/NEFT.
- 6.2 The Earnest Money/Security Deposit shall be valid upto a period of five years or the complete conclusion of the contractual obligations to the complete satisfaction of both the BIDDER and BUYER, including warranty period, whichever is later.
- 6.3 In the case of successful BIDDER a clause would also be incorporated in the Article pertaining to Performance Bond in the Purchase Contract that the provisions of Sanctions for violation shall be applicable for forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- 6.4 No interest shall be payable by the BUYER to the BIDDER on Earnest Money/Security Deposit for the period of its currency.

7. SANCTIONS FOR VIOLATIONS

7.1 Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the BUYER to take all or any one of the following actions, wherever required:-

- (i) To immediately call off the pre contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.
- (ii) To forfeit fully or partially the Earnest Money Deposit (in pre-cotract stage) and/or Security Deposit/Performance Bond (after the contract is signed), as decided by the BUYER and the BUYER shall not be required to assign any reason therefore.
- (iii) To immediately cancel the contract, if already signed without giving any compensation to the BIDDER.
- (iv) To recover all sums already paid by the BUYER, and in case of the Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate while in case of a BIDDER from a country other than India with Interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from the BUYER in connection with any other contract such outstanding payment could also be utilized to recover the aforesaid sum and interest.
- (v) To encash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along with interest.
- (vi)To cancel all or any other contracts with the BIDDER and the BIDDER shall be liable to pay compensation for any loss or damage to the BUYER resulting from such cancellation/rescission and the BUYER shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
- (vii) To debar the BIDDER from participating in future bidding processes of the Government of Chhattisgarh for a minimum period of five years, which may be further extended at the discretion of the BUYER
- (viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middlemen or agent or broken with a view to securing the contract.
- (ix) In cases where irrevocable Letters of Credit have been received in respect of any contract sighed by the BUYER with the BIDDER, the same shall not be opened.
- (x) If the BIDDER or any employee or the BIDDER or any person acting on behalf of the BIDDER, either directly or indirectly, is closely related to any of the officers of the BUYER, or alternatively, if any close relative of an officer of the BUYER has financial interest/stake in the BIDDER's firm, the same shall be disclosed by the BIDDER at the time of filling of RCO. Any failure to disclose the interest involved shall entitle the BUYER to rescind the contract without payment of any compensation to the BIDDER.

The term 'close relative' for this purpose would mean spouse whether residing with the Government servant or not, but not include a spouse separated from the Government servant by a decree or order of a competent court; son or daughter or step son or step daughter and wholly dependent upon Government servant, but does not include a child or step child who is no longer in any way dependent upon the Government servant or of whose custody the Government servant has been deprived of by or under any law; any other person related, whether by blood or marriage, to the Government servant or to the Government servant's wife or husband and wholly dependent upon Government servant.

(xi) The BIDDER shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the BUYER, and if he does so, the BUYER shall be entitled forthwith to rescind the contract and all other contracts with the BIDDER. - 9.5 As soon as the Monitor notices, or has reason to believe, a violation of this Pact, he will so inform the Authority designated by the BUYER.
- 9.6The Monitor will submit a written report to the designated Authority of BUYER/Secretary in the Department/within 8 to 10 weeks from the date of reference or intimation to him by the BUYER/BIDDER and, should the occasion arise, submit proposals for correcting problematic situations.

10. FACILITATION OF INVESTIGATION

In case of any allegation of violation of any provisions of this Pact or payment of commission, the BUYER or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information of the relevant documents and shall extend all possible help for the purpose of such examination.

11. LAW AND PLACE OF JURISDICTION

This Pact is subject to Indian Law, the place of performance and jurisdiction shall be the seat of the BUYER.

12. <u>OTHER LEGAL ACTIONS</u>

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the any other law in force relating to any civil or criminal proceedings.
